This document sets out your rights relating to the privacy of the personal information provided to us when you apply for credit from HCFI and any other information provided to us subsequently in connection with the application for credit and any credit granted. Once we receive your application for credit, we will open a file on you. The purposes for opening a file on you are to:

- evaluate your application and your eligibility for credit;
- assess your solvency; and
- decide whether you are approved for a conditional sales agreement and/or lease agreement for goods: automobiles, motorcycles, all-terrain vehicles, power equipment, outboard motors and marine products, as applicable.

If you are approved and you enter into such an agreement with us, we will also use this information for contract management and marketing purposes. Contract management includes notably credit, billing, collection, lien registration, insurance tracking and service and warranty purposes. Marketing includes the marketing and promotion of products, goods and services which we believe may be of interest to you. We will maintain your file for as long as we have a business relationship with you. Once our business relationship with you has ended, we and the Dealer (as defined below) may still use your identification details (nominative information) (such as your name, address(es) and telephone number(s)) only for marketing purposes. You authorize telemarketing telecommunications to be made by or on behalf of us or the Dealer to you at your Home Phone Number set forth on the reverse side.
